Further, the Trading Window shall, pursuant to the Code of Conduct for prevention of Insider Trading under the SEBI (Prohibition of Insider Trading) Regulations, 1992, remain closed from today i.e. November 11, 2019 to 16<sup>th</sup> December, 2019 (both days inclusive) and shall re-open on 17<sup>th</sup> December, 2019.

Accordingly, the Promoters, Directors, Designated Employees and all persons covered under the Code have been advised not to deal in the securities of the Company from today i.e. November 11, 2019 to 16<sup>th</sup> December, 2019 (both days inclusive) and shall re-open on 17<sup>th</sup> December, 2019.
